PRODUCT DESCRIPTION

Air Freshener refill for use with Watchman Air Fresheners (codes : 0697100, 0690800) and Ripple Air Freshener code 06971000.

Refill comprises HDPE bottle, filled with fragrance solution, 100mcl spray pump crimped to the neck and white plastic transit cap fitted to protect pump during transit. Example shown below.

PRODUCT PERFORMANCE

Intended to fragrance rooms up to 85 cubic metres.
Fragrance uses Micromorph technology which by physical interaction prevents evaporation of the malodour molecules and by chemical interaction with malodour molecules and the nose receptors helps to reduce the malodour. Spraying the refill against hard surfaces can cause staining. Dispenser for refill should always be positioned to spray into the washroom and away from walls ceiling maintaining 2.2m height from the floor as shown on the refill label.

Storage temperature 0 – 30 °C
Storage conditions Store away from sources of ignition. If possible store in flammable liquid store to contain pool fire if product were to be set alight.

Refill uses mechanical spray pump to atomise fragrance, refill is not pressurised and does not use CFC propellant. Particle size above threshold for respiratory risk.
Fragrance tested extensively for skin irritation when in contact with good and broken skin. No evidence of dermal irritation found.
