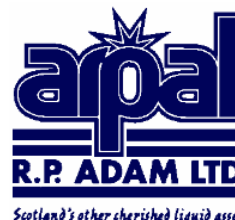

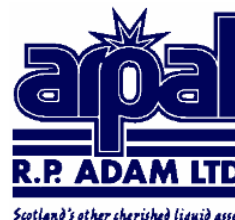
7. HANDLING AND STORAGE:
