2. Composition/information on ingredients

Product Contains:

Sodium alkylaryl sulphonate	35 – 40%
Sodium sulphonate	5 – 10%
Sodium chloride	40 – 45%
Anti limescale	5 – 10%
Colour	1.5 – 2.5%
Perfume	up to 4%
Microbial powder	1 – 2%

3. Hazards Identification

Irritant

Irritating to eyes and skin

4. First Aid Measures

Eyes	Rinse out thoroughly with plenty of water Seek medical attention if necessary
Skin	Wash with soap and water. Rinse thoroughly
Ingestion	Do not induce vomiting. Give plenty of water to drink Seek prompt medical attention
Inhalation	Remove patient to fresh air. Rest and keep warm. Seek medical attention if problem persist

10. Stability & Reactivity

Stable - No hazardous reactions with proper storage and handling

11. Toxicological Information

The product is irritant to eyes and skin

Inhalation of finely divided material may irritate the mucous membrane

Sodium alkylaryl sulphonate – acute oral toxicity LD50 (rat) – 2150mg/kg

12. Ecological Information

Alkylaryl sulphonate is completely biodegradable and will be degraded in a few days.

13. Disposable Considerations

Waste or surplus material should be disposed of in accordance with local authority regulations

Material may be incinerated or taken to landfill.
